

Scrip Fundraising Program Agreement

Saint Jude the Apostle School

Saint Jude the Apostle Home and School Association (referred to herein as “we”, “us”, and “our”) sponsors a Scrip Program that allows you to purchase Scrip. The Scrip you purchase through our program generates rebates from participating retailers. Twenty-five percent of all rebates will be retained as fundraising for Home and School sponsored programs. You understand that your child will be responsible for the safe transport of the Scrip from school to your home and certify that you have discussed the responsibilities associated with the transport of the Scrip with your child. You agree that once the school delivers the Scrip to your child that the school is not responsible for any Scrip that is lost, stolen or misplaced.

I will pick up my Scrip in the school office.

NOTE: If Scrip is offered during June, July, or August, Scrip pick up is the only delivery option.

You agree to indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover checks or ACH transfers you use to pay for your Scrip. Once you are notified of your insufficient funds, you will have 10 days to submit full payment to us, including any bank fees accrued. During this time period your Scrip account will be placed on hold and you will not be able to purchase Scrip. Once payment is received, your account will be reinstated. In the event you are notified twice of insufficient funds within a single Scrip year, (May 1st –April 30th), you will need to pay for future Scrip orders by cash only for the remainder of that Scrip year.

If you have purchased Scrip and earned a rebate, but no longer have school fees due to us and you haven't designated the balance of your rebates to any other option, your rebate balance will go to Home and School.

We make no representations or warranties of any kind with respect to the Great Lakes Scrip Company. This agreement can be terminated by either of us upon 10 days advance notice to the other.
